If you are in need of food assistance, please come to the church at 9320 N. Congress Street in New Market. Our food pantry is open on the 3rd Thursday of each month. **During** the winter months (Nov., Dec., Jan., Feb., and Mar.) the food distribution hours will be from 1 pm to 4:30 pm. For the remaining months the distribution hours will be from 1 pm to 5 pm. The food pantry entrance is located at the rear

of the church off John Sevier Road. No ID or paperwork is needed. You will receive a printed menu with all the food items that are being distributed on that day including fresh foods and produce. After a brief registration, your food order will be filled, and you will receive the items requested from your menu. If you are physically unable to come down the steps into the pantry, an interviewer will come outside to register you.

Bad Weather Policy: If Shenandoah County schools are closed, the Food Pantry will be closed also and will reopen the next day (Friday) for regular hours. If schools are closed on Friday, we will open the next day school is open. If bad weather begins once we are open, we may need to close early and reopen using the policy above. If in doubt, please call the church office to make sure we are open 540-740-8959.
