Hindu Temple of Canton – Facility Usage Rules & Guidelines



1. Compliance with Law: Users must follow all federal, state, and local laws, regulations, and ordinances.
2. Liability & Insurance: Users are responsible for any legal liabilities arising from their event. Adequate insurance is required to cover themselves, their guests, and the Temple for any damage or injuries.
3. Indemnification: Users agree to hold the Temple, its trustees, officers, members, agents, and employees harmless from any claims, damages, or expenses (including legal fees) arising from their use of the facility.
4. Prohibited Activities: No political activities, non-vegetarian food, alcohol, smoking, or fundraising without prior written approval.
5. Advertising & Sales: Selling merchandise or distributing materials is prohibited unless directly related to the event and approved in advance. Admission fees or collections require written Temple Board consent.
6. Decorations & Property
 - No decorations on walls, ceilings, floors, tables, or chairs using tape, staples, nails, glue, etc.
 - All decorations must be removed within 4 hours after the event.
 - No confetti, flowers on carpets, or food on stage/green room.
7. Furniture & Equipment: Only Temple furniture may be used. Any additional equipment or property may not be moved, removed, or used without prior permission.
8. Catering & Cooking
 - Only Temple-approved caterers and decorators are allowed.
 - Cooking is only allowed in the kitchen (per City Fire Code).
 - A separate agreement with the caterer ensures cleanliness and responsibility.
9. Facility Condition: Users must return the premises, including kitchen and banquet areas, to the same condition as found. Any damage must be paid in full before leaving the premises.
10. Bookings & Payments
 - All bookings are subject to availability.
 - Reservations are confirmed only after payment.
 - To confirm: 25% upfront; occupancy permit requires remaining 75% + \$500 security deposit.
 - For events booked less than 15 days in advance, full payment is required.
 - Occupancy permit must be obtained 15 days before the event.
11. Cultural Classes: For cultural classes, if 35% of total collections are less than the minimum charge for the booked area, the user is responsible for paying the difference.
12. Security Deposit: A \$500 refundable deposit is required. It will be refunded within 7 business days after inspection, minus any damage. Users are responsible for vendor-caused damages (\$100 minimum per incident).
13. Access & Extra Time
 - Premises are available only during approved hours.
 - Early access or additional setup time is subject to a \$50/hour fee and prior approval.
14. Cancellation: Non-refundable deposits are forfeited unless cancellation is due to emergencies (medical or death), at the Temple Board's discretion.
15. Post-Event: All personal and rented items must be removed immediately after the event; nothing may be left overnight.
16. Special Notes
 - Life Members are entitled to one complimentary use of the banquet hall, strictly personal and non-transferable.
 - Food is only allowed on properly set-up tables; electric grills cannot be used on plastic tables.

Note: The Temple Board reserves the right to modify these rules at any time.

By signing this rental agreement, the renter agrees to pay for any damages or losses to the property and takes full responsibility for the guests who attend the event.
