St. Paul’s UMC Wedding Policies:

If the couple plans to be married by Rev. David Czeisel, they are required to complete a minimum of three mandatory premarital counseling sessions with the pastor. If possible, couples are strongly encouraged to attend worship with the church on at least three Sunday mornings prior to the wedding.

Couples who reside out-of-state may attend a premarital counseling course approved by the pastor. Listed below are the baseline donations associated with having a wedding at St. Paul’s United Methodist Church. These monies reflect the cost of using the space and the labor and time associated with the actual wedding day and other preparations necessary. The donations help support the various ministries of the church.

The “Use of Space” donations are subject to change if those being married are active members of the St. Paul’s UMC and/or have an annual giving greater than the relevant “Use of Space” donations.

Donations/Honorariums:
