# 9. Financial Reports

- Peter Flemming reviewed the Financial Information.
- We ended up with a net income figure of \$5,310.
- Revenue up over 2022 at \$720,429 against a budget of \$775,600.
- Investment Income for the 4<sup>th</sup> quarter is not yet available, some things are a bit behind as the diocesan finance office is undergoing restructuring. The amount yet to be received is \$63,000.
- It was noted that the contract for the former Engagement Leader has ended.
- The office ran without a photocopier lease in 2023.

#### **MOTION:**

Moved by Heather MacEachern/seconded by Frank Lovely that the 2023 financial report be accepted and received. Motion carried.

# 10. 2024 Budget

- Peter reviewed donor restricted offerings, and gave a description of what these are.
- What happened to the idea of a Capital Campaign? Covid 19 made it necessary to postpone a Campaign. The idea hasn't disappeared, it has just been put on hold for the time being.
- Discussion regarding sound system improvements the ultimate goal is to upgrade the sound deck, cameras etc. It will take approximately \$20,000 to do the work in question.
- Education around use of the existing microphones would be a good idea in the meantime.
- Ministries/Missional/Engagement (Engagement Leader/other p. 37) this was not an overspend, but rather a flow through grant for the Square Roots collaboration with Spencer House.
- **Tour Guide:** The Cathedral has not received (but has applied) for Canada Summer Job funding for this position since the pandemic. Could we fund a Tour Guide internally? It was suggested that the budget be amended, adding \$5,000 for Tour Guide expense, concern expressed about adding this without having the proper support pieces in place. The Tour Guide item will added to Council's agenda.
- The budget was very carefully prepared, looking carefully at pastoral care and engagement.
- Refugee Sponsorship funds have now been transferred to the Diocese as part of a new system.
- It was noted that for consideration in the budget, requests are brought to Council by the committee representing the request, by mid-January.
- Council minutes to be posted on the bulletin board to enhance communication.

Moved by Maureen Yeats/seconded by Helen Ryding that the 2024 budget be amended to reflect a \$5000 addition to Tour Guide expense. Motion defeated.

It is wonderful to be part of such a dedicated and thoughtful team. # Worship and Faith Formation

Many kudos to the Sunday School and their teachers for a memorable Christmas pageant and youth led services to enhance our worship and to enrich our faith formation. We have enjoyed a variety of opportunities from pumpkin carving to bar-b-ques to bring us together for fellowship and celebration.

We have focused this year on ensuring we have completed Diocesan SafeR Church training on abuse prevention and risk management for those who work with children, youth, or vulnerable people. We continue to look for opportunities to support families with young children at the 11:00 service and to promote a welcoming and inclusive community with opportunities for worship that span a breadth of Anglican tradition.

## **Outreach and Engagement**

Our Outreach Committee continued to do incredible work to support the community, at our doorstep and through refugee sponsorship, even highlighting new ways to engage through Soup to the Doorstep and the Jesse Tree. This ministry continues to be a great source of meaning for our congregation.

# **Building the Future**

With the selection of our Parochial Committee, we have worked through this year on creating a strong role description for a new 'Assistant Priest for Congregation Life and Community Engagement' while Sarah has taken on a greater role to support communications. The process of calling a new priest has taken time as there have been several steps along the way. We are very grateful for the commitment of the Parochial Committee to work so diligently to move us forward.

The 'Stitchery Project' has highlighted the incredible needlepoint of the parish. Many thanks to the dedicated leadership team who brought this work forward.

And to Bruce Langille and Ken Dauphinee who have kept the building in good repair and supported the addition of AED equipment and naloxone training, we offer our sincere gratitude.

We are also part of the Anglican Diocesan Centre Corporation and attend the Annual General Meeting to represent the congregation alongside Stephen Osler and Peter Flemming.

# **Equity and Inclusion, Belonging and Justice**

Accessibility has been a focus this year, from parking to open seating to washrooms to an improved sound system, we are trying to be more intentional about how our space and our community can facilitate inclusion and belonging and how our communications can reflect the diversity of our congregation.

# The Rector & Dean's Report

O God of unchangeable power and eternal light, look favourably on your whole Church, that wonderful and sacred mystery.

By the effectual working of your providence, carry out in tranquility the plan of salvation.

Let the whole world see and know that things which were cast down are being raised up, and things which had grown old are being made new, and that all things are being brought to their perfection by him through whom all things were made, your Son Jesus Christ our Lord; who lives and reigns with you, in the unity of the Holy Spirit, one God, for ever and ever. Amen.

The prayer above, from the Book of Common Prayer, is offered as a prayer for; "The Church Universal", and in the Book of Alternative Services, it is incorporated into the liturgy for Good Friday. It is a reminder, first and foremost of God's overarching providence. It is about trust and faith. Trust and faith that in partnership with God, we can do amazing things. Renewal and new life are always the hope and possibility in our relationship with God. The annual report, which you hold in your hands, bears witness to this reality.

At our Annual Meeting last year, we reflected back on the year 2023 as we emerged from the restrictions and uncertainty of the pandemic. Our *Rising Up Plan*, first visioned before the pandemic's arrival, charted a course to lead us forward. With the four pivotal categories of focus; Worship and Faith Formation, Outreach and Engagement, Equity and Inclusion -Belonging and Justice, and Building for the Future, we seek to raise awareness and challenge ourselves to continue to grow as a vibrant community of faith.

This past year, 2024, I believe, has borne witness to the fruits of this foundational effort. Indeed, things; "which were cast down are being raised up, and things which had grown old are being made new". This past year has seen continued growth with respect to finances, worship attendance, Sunday School, outreach ministries, and volunteer engagement and initiatives. All of this, I might add, despite the fact that for nearly half the year, (and ongoing) Cathedral Lane has been an active construction site, severely limiting access to the Cathedral building and compromising our already meagre parking offerings.

A few highlights that reflect the Cathedral's life and witness this past year include:

- Say Yes To Kids initiative
- White Ribbon Sunday
- Outreach undertakings including Adopt a Meal and Soup to Doorstep
- Shrove Tuesday Pancake Supper

- Cathedral Ladies Who Lunch
- Weekly Bible Study
- Regional Council Advent event
- Stitchery Project
- Christian Meditation groups, online and in-person
- Cathedral interior restoration work
- Replacement of transept roofing
- Installation of AED (Automated External Defibrillator) and training
- Installation of new recording/sound system

In the fall of 2024, with a mandate from the Annual General Meeting, the Cathedral elected a Parochial Committee to begin the process of defining a position description and engaging in a search process for a second ordained staff person for the Cathedral. That work, at the time of this writing, is ongoing, but I am deeply grateful for the energy, effort, and integrity of those who are serving on that committee and look forward to the fulfillment of their task.

I also want to commend the ministry of those who serve on our Cathedral Council. They continue to vision and implement a path for growth, dealing with the ongoing management of this large corporate Cathedral organization while also encouraging opportunities for deeper understanding of what it means to be a community of faith in an ever-changing world. The executive members of Council; Zachary Bath (Warden), Jackie Pidduck (Dean's Warden), and Stephen Osler (Council Chair) are not only deeply committed to their roles, and sensitive to the complexities of this varied and diverse Cathedral community, but also are a tremendous support to me personally. The Honorable Mayann Francis, who now holds the designation of "Warden Emerita" continues to offer her support and I am thankful for her love of this Cathedral and for God. Along with Sarah Underwood, our Cathedral Administrator, (without whom my ministry would not be manageable) we are extremely blessed to have a team dedicated to helping us to move forward. Financially we are under the very capable oversight of Peter Flemming in the role of treasurer, and Lois Marshall our bookkeeper.

As always, the list of individuals who carry out the many and varied ministries of our Cathedral is a long list. And, as always, I am aware that in naming some, I may forget others, so I beg your forgiveness in advance, and in the words of the Prayer Book; "and those whom we have forgotten, do thou, O Lord, remember."

For those who serve on our liturgical ministry team, always, and on occasion, I am deeply grateful. For the role that Ray Carter carries on among us, for his leadership in worship, study groups, and a myriad of outreach projects, and his advocacy for refugees, we are indeed blessed. One of the mandates of a Deacon is; "to interpret to the Church the needs, concerns, and hopes of the world." That is a critical voice for us to hear. This past year the Rev. Canon Stephen Booth, The Rev. Dr. Heather McCance, The Rev. Keirsten Wells, The Rev. Canon Lisa Vaughn, The Rev. Taunya Dawson have all been of great support, and although retired, The Rev. Dr. Helen Ryding and The Rev. Heather MacEachern continue to offer their services when needed. We also have had the opportunity to be a part of the journeys of two students from Atlantic School of Theology this past year, Blane Finney and Will Barton.

It is also more than apparent that there are many moving pieces when it comes to worship at our Cathedral, and there are many who offer their contributions. We are richly blessed with a group of greeters who welcome all who would come through our Cathedral doors. Whether life-long members or the newly curious, all are made to feel at home. Part of that welcome extends through hospitality offered around the coffee table following services, a big Thank You to all who contribute.

Our Licensed Lay Ministers; Margy Withrow, Heather Carter, Joseph Poon, Susan Drain, Bill Black, Maureen Yeats, and Dylan Stewart lend their assistance in word and sacrament. A new team of "videographers" have come onboard to enable us to live-stream our services, a challenging but fulfilling role (we are happy to welcome others!). Maureen Yeats: enough cannot be said of her dedicated ministry in her role as Sacristan. From creating altar hangings and banners, to daily and weekly attention to providing all the elements required for services at the Cathedral, as well as at Diocesan events, Maureen's organizational skills and attention to detail are a marvel to behold. AND, in her spare time she is one of the videographers! Mary Lib Bethune coordinates the floral displays for Sundays and special events at the Cathedral, while Gay Dennis and Judi MacDonald attend to linens for services.

Within our Diocese, and within the city of Halifax, our Cathedral has built a reputation for musical excellence. Under the leadership of our Director Paul Halley, and assisted by Nick Halley, our choral music at our 11 am worship and our "Sundays at Four" series are simply magnificent! To them, and to the choristers, we are deeply grateful. We are also pleased to welcome the Capella Regalis Boys, and Girls choirs when they have opportunity to add their voices to our own Cathedral choir. I would be remiss if I did not mention James Burchill, our "organ emeritus" who died this past summer. His love for both the choral music tradition, and our Cathedral's organ, paved the way for what we now enjoy. Our 9:30 worship continues to blossom under the guidance of pianist Russ Hall, who along with Pauline Josey (violin) and other musicians from time to time, plus a dedicated chorus, make the gathered space around the font a beautiful and spiritual experience.

Our 9:30 community has become the centre for our Sunday School programming and the presence of young people there adds a wonderful dynamic to the worship. The unsung hero's who offer their talents, energy (and patience) as teachers includes Bill Black, Sarah Cooper, Karen Cooper, Elissa Barnard, Gay Osler, Keirsten Wells and Jackie Pidduck and occasional guests and parents. Bill Black's older students, as a class, also lead worship on occasion, and have become a part of our 4 pm Christmas Eve tradition.

While my reflections speak of the many and varied "things" that happen in and through our Cathedral, the physical plant is of no less importance! This building is now 114 years 'young' and its upkeep and maintenance remains a creative challenge. The lovely interior space which we see, can blind us to what we can't see. This past year saw interior restoration work carried out, and a major section of our roof replaced. More roof work is anticipated in 2025 which will help alleviate water infiltration, and as a result we can address other areas that need interior repair and painting. In future years a major restoration of the 'east' wall will need to be undertaken. On your behalf I offer continued thanks to Bruce Langille who coordinates the scheduling of annual maintenance, including assuring that we have heat in the winter months and shoulder seasons, and to Ken Dauphinee who along with being the point person for negotiating with contractors for major projects, can often be found lending a hand to smaller projects and often can be seen pushing a mower in the summer. Along with Ivana Starcevic, whose

services we share with the ADCC (Diocesan Centre Corporation), we are able to provide clean, safe, and functional facilities to a very busy building.

In concluding this "look back" I want to offer my gratitude for the guidance, support, and ministry of our Bishop, Sandra Fyfe. She takes a keen interest in who we are and what we do here, and is a source of ongoing inspiration. May we continue to be a place where; things which had grown old are being made new, and together advance God's kingdom.

Cathedral Ladies Who Lunch formed in late 2023. Our purpose is to engender and sustain friendships amongst the parishioners at Cathedral Church of All Saints. We recognize the importance of getting to know one another at a deeper level than is practical in the few minutes available before and after services. To that end, we gather together to share a meal and engage in conversation that strengthens our understanding of each other and builds community.

We gather together in the Great Hall for a potluck luncheon every two to three months. During 2024, we averaged 18 attendees at each event. We enjoyed a wonderful meal (funny how unplanned potlucks always turn out great) and equally wonderful conversations. We take some time at each luncheon to go around the table and share something about ourselves. Often we share information about charitable projects individuals are working on. For example, this year one attendee brought samples of some lovely heart-shaped pillows and drain bags she and her colleagues are making for breast cancer patients who've experienced surgery. This position will no doubt be central with continued worship and The Rising Up Plan in years to come.

We have a strong and diverse growing congregation with numbers increasing for all services and the collection plates have been generously seen to in comparison to recent former years.

The outreach committee has extended their presence in ongoing and new initiatives such as Shelter Nova Scotia, adopt a Meal soup kitchens, soup to your doorstep with 21 recipients (last count) and the Christmas Jesse tree, not to mention a new collections crib for children in need.

# Report of the Director of Music

Choral services for fiscal year 2024 began on Sunday January 7th, the 1st Sunday after the Epiphany. The 'Sundays at Four' series resumed on February 4th with an Evensong offered by the Cathedral Choir, and following Evensongs were offered by both the Men & Boys of Capella Regalis and the Men & Girls of Capella Regalis. The Ash Wednesday evening service on February 14th featured the choir's singing of the famous *Miserere Mei* by Allegri. As long as we have sopranos able to sing those high 'C's, this tradition will continue! Evensongs for the first five Sundays in Lent alternated between the Cathedral Choir and Capella Regalis. On March 24th, Palm Sunday, the Cathedral Choir presented their second "Passion: Music of a Thousand Years" concert. The choir sang a wide range of Passiontide repertoire from 12th century Gregorian chant, through Tallis and Byrd, Shaker songs and African American Spirituals, to Samuel Barber and contemporary composers. These pieces were sung from various locations throughout the Cathedral. Several compositions required two or more groups of choristers singing from different locations. The impact was all that I had hoped. Audience members were thrilled with the effect of the voices spread throughout the building. Many people confessed they had no idea just how wonderful the Cathedral's acoustics were.

Holy Week, as always, comprised choral services at 7 p.m. on Holy Tuesday and Maundy Thursday and the noon service on Good Friday. The Vigil on Holy Saturday was particularly dramatic and on Easter Day we celebrated the resurrection with our annual "Jazz Easter" which seems to draw in the crowds. The costs for this service – band, sound engineer and sound gear – were underwritten by Larry and Gail Ashley. Sincere thanks to them for making "Jazz Easter" possible.

After a break for 'Low Sunday' the choir resumed singing at the 11 a.m. Eucharists on April 14th, continuing through June 9th. The 'Sundays at Four' Evensongs ran from April 21st through the end of May. Capella Regalis presented their End-of-Season Concert on the last Sunday of the series.

Sadly at this point in the year the choir sang at memorial services for three men who were major figures in the life of the Cathedral and were great supporters of the music programme. John Cooper's service, a full Eucharist, was held on April 5<sup>th</sup>. James Burchill had requested a memorial Evensong which was held on June 30<sup>th</sup>. And Clay Coveyduck's memorial service was held on July 9<sup>th</sup>. All the services were very moving and powerful affirmations of faith. These three pillars of the community are sorely missed.

After the summer break the choir returned for choral services on September 15<sup>th</sup> and the 'Sundays at Four' series resumed on September 29<sup>th</sup> with Evensong for St. Michael & All Angels offered by the Men & Boys of Capella Regalis. On Friday, November 1<sup>st</sup>, we carried on the tradition with the Cathedral Choir and the choirs of Capella Regalis joining forces in a Festal Evensong at 7 p.m. to mark our 'patronal' day. The attendance at this service is always impressive.

On Sunday November 10<sup>th</sup> (Remembrance Sunday) at 4 p.m. the Cathedral Choir joined the choirs of Capella Regalis in the 2<sup>nd</sup> annual concert called "For All the City". This year's program featured Mozart's *Requiem* with the choirs, orchestra and soloists. As was the case in 2023, the concert was free of charge. Thanks to the generosity of the John C. Kerr Family Foundation and Edmonds Landscape and Construction Services Limited and five individual sponsors, the considerable expenses for this event

were underwritten so that income from ticket sales was not required. The Cathedral was filled to capacity. Capella Regalis had sent out a notice saying 350 reserved seats had been set aside and were available online in advance. All those seats were gone within a day. It turns out that Mozart's *Requiem* is second only to Handel's *Messiah* in popular appeal.

Both the 11 a.m. Eucharist and the Evensong for the Last Sunday after Pentecost, November 24<sup>th</sup> were sung by the Men & Boys of Capella Regalis who enjoyed a potluck lunch in the Great Hall between services. The Girls & Men sang the Evensong on Advent Sunday, December 1<sup>st</sup>. On Sunday December 15<sup>th</sup> at 4 p.m. the Cathedral Choir presented their third annual presentation of "A Rose in Winter" having performed it at St. John's in Lunenburg the day before. The Sunday following, the Men & Boys of Capella Regalis presented two performances of "A Chorister's Christmas" at 4 and 7 p.m. All these Christmas concerts were sold out.

The following Tuesday found us celebrating Christmas Eve with the usual round of services. The late service beginning at 10:30 p.m. with the Cathedral Choir and the Choirs of Capella Regalis and the Maritime Brass is always a highlight for me. Thanks to the generosity of Rose Wilson, who covered the fees for the Maritime Brass, this service has become a major component of our annual Christmas offerings. The congregation continues to grow (in spite of the snow this year).

My focus on the restoration of our magnificent organ continues. The work done on the instrument in June of 2019 was very successful and has made the organ so much more effective. I am in conversation with Robert Hiller and the folks at Casavant regarding the next phase of this project and hope to report to Council in the coming weeks.

I would like to thank all of you who in so many ways support and encourage the singers and instrumentalists who minister in this place. Thank you to Russ Hall and his band of musicians for their offerings at the 9:30 service. Thank you to Nick Halley, Assistant Director, and the members of the Cathedral Choir for their dedication and consistency. Thank you to Scott Beard (Ting) our long-suffering and over-worked music librarian. And thank you to Capella Regalis for adding so much to our yearly round of services and concerts.

And as ever, heartfelt thanks to Sarah Underwood for her calm and efficient handling of a myriad tasks, to Ivana for her cheerful assistance and understanding, and to the Dean for his constant support, counsel and sermons.

# Needlepoint: Sacred Art at the Cathedral Church of All Saints

Perhaps you are not aware that over 100 pieces of Needlepoint were designed and stitched for the Cathedral in the late 1980s! If you look carefully in the Cathedral you will see beautiful hand-stitched items: seat cushions, cushions attached to wooden kneelers, altar rail kneelers, small kneeling cushions for the chairs of St. Stephen's and St. Luke's Chapels, and many more! These beautiful pieces were specially designed for the Cathedral by Geoff Smith, a Toronto-based, Nova Scotia born designer, and stitched by people (mostly women) from the Cathedral and parishes throughout the Diocese of Nova Scotia and Prince Edward Island. According to Charlotte Cochran who headed up the project in the 1980's, "her only regret is that a book commemorating the work of these people [the stitchers] was never done".

Today a team of Cathedral members are seeking to produce a book to commemorate the commitment and skill of the many women and men who created these beautiful items for the Cathedral. The team, consisting of Elissa Barnard, Charlotte Cochran, Gay Osler, Cynthia Pilichos, and headed up by Jane McKay-Nesbitt, has been hard at work on this project since September 2024. They have gained the blessing and support of the Cathedral Council, consulted with conservators in Nova Scotia and archivists in Calgary, created a detailed photographic inventory of the needlepoint items, and have applied for Federal and Anglican Church grants to offset costs. The team is now in the process of cleaning the items (a process that requires a great deal of care) and arranging for appropriate storage of the items in the Cathedral. Stephen Osler has designed a special cabinet to protect and display the items so all can enjoy these beautiful pieces of sacred art.

With the goal of a publication in mind, a professional photographer has been selected to photograph the items, and the team is in the process of hiring a book designer. Some research and writing has also begun. Although aware that many of the original stitchers are deceased, the team is hoping to be able to learn about these individuals and perhaps locate family members who may still be in the area. And of course, if you have any information about any of the stitchers, we would be so pleased to hear from you (email <a href="mailto:elissa.barnard@gmail.com">elissa.barnard@gmail.com</a>).

The original project took over 10 years, and although we do not anticipate spending several years to create a publication, we are aware that this is a massive project. We plan to host a book launch at the Cathedral, and we are grateful that Cate Berry will assist us with planning that event. We will keep you posted as to the timing of the book launch!

Our team has taken on this project as a way of honouring those who have gone before us. We do not want their love for our Cathedral, and their willingness to spend countless hours creating beautiful pieces of sacred art for it, to be forgotten. We hope you will join with us in this worthy endeavour. Your words of encouragement, your prayers, and your financial gifts are welcomed and appreciated.

# **Outreach Committee**

Outreach was very active this year, supporting a number of causes in our neighbourhood and beyond. Cash grants were given to Shelter Nova Scotia, St. George's Youthnet, the Mission to Seafarers, Spencer House, and the PWRDF. Apartment furnishings were supplied to Shelter Nova Scotia. Meals were prepared monthly for the folks at six shelters in the HRM, and we cooked for and served about eight hundred meals at the St Georges soup kitchen. We continued to supply pizza once a month to the folks living at the "191" shelter.

Various needs were collected and supplied to the people who need it including toiletries, puzzle books, art supplies, boots, winter clothing etc.etc. Gift cards were given by the clergy to the needy. Used eyeglasses and hearing aids were collected and dispersed. The "Soup to Doorstep initiative was begun and has grown over its first year, delivering soup to both members and non-members of our Cathedral Family. Christmas gifts were supplied to some families and shoe boxes were filled for Mission to Seafarers.

We welcomed the Almasada family, refugees from Syria, after a six year wait. They are now happily living in Halifax. The Outreach committee also contributed to the support of four other refugees who are awaiting Government processing. The Jessie Tree was strongly supported by the community and we were able to make a better Christmas for the Youth at Phoenix House.

We continue this year and are currently offering a time of fellowship in the Cathedral on Friday's at 1:00PM. Our Lord said "even though you do it for the least of these, you do it for Me."

# **Parochial Committee**

With the AGM last year approving a budget that included an additional clergy role, in late spring Cathedral Council started a visioning process to shape the role of an Assistant Priest for Congregational Life and Community Engagement. This role was described as a full-time Assistant Priest to equip and empower our thriving church community, to ignite faithful imagination and sustain inspired innovation, to support the pastoral care of the congregation and to help us grow as an inclusive, connected community of faith in action.

In conversation with the Bishop, we were tasked to convene a Parochial Committee in accordance with Canon 25 (canons acting as the regulations for the diocese). A special meeting of the congregation was convened and a Parochial Committee elected in early Fall. The committee includes Grace MacIntyre, Cynthia Pilichos, Joseph Poon, and Carmon Stone. In accordance with the canon, the wardens and Dean Paul make up the rest of the committee. This group then worked to finalize the role description and develop a simplified parish profile that highlighted our Rising Up Plan in consultation with Cathedral Council.

With this work underway, we set about meeting with different people to help us build our skills as a team, including Bill Black to help shape a more effective interview template, Pethrona Russell to help us understand human rights, equity and diversity in hiring practices, and Lisa Vaughn who spoke to us about ministry and mission. Meanwhile, we were consulting with the Bishop and providing the necessary documentation to demonstrate our financial capacity to fund the new role. As Bishop Sandra ultimately is the one to call a new priest, with her approval, the diocesan office posted the position early in 2025. We are very thankful for the time and talent shared with us by each of these individuals who have strengthened us as a team.

From here, the Bishop reviews the applications, speaks to the Bishops of any applicants who may be outside of the diocese and meets with the Parochial Committee to provide applications. From there our committee worked to determine who we would interview. The interview process will take time to complete as different rounds of interviews and team meetings have been needed. We have appreciated the gifts and skills of the applicants and are looking forward to completing this process as soon as we can. As we are required to keep the deliberations of the committee confidential. We are ever grateful for the patience and prayers of the congregation as we move through this process. We are also grateful for the work done to support the Rising Up Plan that helped us to shape an attractive position description and for a congregation that people want to be part of!

# **Report of the Property Committee**

For the year 2024, ongoing maintenance and upkeep at the Cathedral was undertaken. Only one project, the replacement of the roof shingles over the Transept was considered a capital restoration project.

- An extensive State-of-the-Art Yamaha sound and recording system with the valued assistance from Dean Paul was installed giving enhanced in-house and online streaming audio services. We acknowledge with utmost thanks, the addition, design and craftmanship of a sound booth which Dean Paul crafted from materials reclaimed and restored from our former Bishop's House and Deanery. The finished unit is a testament in part to the love and respect Dean Paul offers each and every day in his ministry at our Cathedral.
- Annual inspection of the backflow value connector to the Halifax water system. The plumber filled the required yearly report on our behalf.
- Annual inspection for the fire alarm panel, monitors, pull stations, emergency lightning exit lights, sirens, flashing emergency lights, replaced worn out parts in the system. Required report done for the Fire Department.
- The boilers were inspected and adjusted four times a year during the heating system. Summer months to keep system from seizing up the boilers were on a timer which turns system on and off each week but not generate heat. As well, replaced a leaking actuator and pressure relief valve. The expansions tanks were drained of water.
- Fire safety inspection requiring labeled piping, painted gas meter and sleeved piping wall penetration by meter.

- Basement door repaired but will need to be replaced in 2025.
- Fire extinguisher inspected and replacement was required.
- A 40 gallon hot water tank was replaced.
- Repair, restoration, and paint was completed on 6 large wall panels.
- Landscaping service was required to repair shrubbery at the main door entrance.
- A gifted AED defibrillator medical device unit was installed which enhanced our emergency supports. Subsequently, parishioners attended a First Aid, CPR, AED and Naloxone Training session.
- Interior wood trim was needed to complete the unfinished work of our front entrance doors.
- An application for a free energy audit was submitted to Ecology Action. We are awaiting their reply.

# Looking ahead to 2025:

- To re-shingle 2 roof sections of the Cathedral
- To replace 2 exit doors.
- To repair, oil and clean the fabric material on 270 chairs located in the Nave.
- To repair and refresh spaces in the porch area adjacent the Vestry and Amalatory.

In submitting this report, I extend a special thanks to Bruce and Loretta Langille for their continuous dedication in overseeing the multi tasks that keep the Cathedral operational.

# Say Yes! to Kids (SYTK) at the Cathedral

Say Yes! to Kids (SYTK) at the Cathedral: Growing Community and Connection
The Cathedral's leadership role with SYTK was recently acknowledged in the Anglican Foundation
Winter 2025 Update, noting our emphasis on growing community and connection: "Say Yes! to Kids
has been a great way for us to reach outside our walls each spring to connect with a community partner and adopt a youth cause. Whether supporting recreation or arts programs, SYTK is an opportunity
to show Haligonians that the Cathedral cares about young people!" (Cynthia Pilcihos).

*SYTK* is an annual fundraising appeal sponsored by the Anglican Foundation of Canada (AFC). Launched in 2021 to encourage church-led pandemic recovery programs and initiatives, the *SYTK* movement has now provided \$755,000 in funding to more than 150 beneficiaries and fundraising partners for youth-focused ministry and outreach across the Anglican Church of Canada.

The marketing, communication and financial support of the Anglican Foundation to parishes and Anglican groups in executing this Peer-to-Peer (P2P) fundraising approach of *SYTK* is outstanding. All *SYTK* projects have benefitted from the marketing and communication talents of Michelle Hauser, Development and Communication Officer for the Foundation, and from the AFC Angel Donor matching gift program. We are all very grateful to the lead donors who have championed this cause over the past 4 years with donations totaling more than \$100,000!

The Cathedral Church of All Saints has been a great supporter of *Say Yes! to Kids* from the beginning, being the only Cathedral in the country for several years to participate. This leadership role of the Cathedral has helped the Diocese of NS & PEI be a front runner with *SYTK* in the Anglican Church of Canada. For example, in 2024, our Diocese ran 6 *SYTK* teams, with the Cathedral's team, led by Cate Berry, supporting the *THRIVE* Girls' Choir, a unique performance choir of girls grades 5 – 12, offering a Christian and mainstream repertoire of music. As a key component of *THRIVE* Education, with the purpose of *empowering youth to come fully alive*, the *THRIVE* Girls' Choir is high energy, offering, as well, leadership development for the participants.

AFC's Executive Director, Dr. Scott Brubacher, notes that the top three ministry impact zones [for *Say Yes! to Kids*] have been faith formation, arts and education, and outdoor recreation. The projects at the Cathedral have been in the impact zones of arts and education (*THRIVE*) and outdoor recreation (recreation opportunities for refugee children in NS and day camp for the children of Halifax's Ward 5 Neighbourhood Centre).

The Cathedral's *SYTK* projects are all ones that have reached out to the community and have helped in actualizing the engagement and outreach priority of the Cathedral's *Rising Up Plan*. This focus continues for the Cathedral's *SYTK 2025*, under the leadership of **Cate Berry**: the *Youth Project NS* (<a href="https://youthproject.ns.ca/">https://youthproject.ns.ca/</a>), a youth-led enterprise that supports youth around issues of sexual identity and orientation, with the goal of making Nova Scotia a safer, healthier, and happier place for 2SLGBTQ+ youth through education, programming, drop-ins, and camps. It is particularly the 3- day residence *Camp Coyote* and the *Day Camp Seahorse* that the Cathedral's *SYTK 2025* project will support. This provides an opportunity for the Cathedral to confirm its commitment to being an inclusive and affirming congregation - your support for the Cathedral's *SYTK 2025* is welcome and greatly appreciated!

# **Congregation of the Cathedral Church of All Saints**

## **Notes to the Financial Statements**

## 1. Status and Nature of Operations

The Cathedral Church of All Saints operates as a registered charity located in Halifax, Nova Scotia. It is the site for worship and other services for the congregation and serves as the Cathedral for the Diocese of Nova Scotia and Prince Edward Island.

# 2. Adoption of CICA Accounting Principles for Not for Profit Organizations

The Cathedral has incorporated changes in the format to the Financial Statements to bring them in line with CICA Restricted Fund Accounting standards. The financial statements have been reformatted and some of the Funds have been re-categorized.

## 3. Summary of Significant Accounting Policies

## **Fund Accounting**

The Cathedral follows the Restricted Fund Method of accounting for contributions.

1.0 Operating Funds are used to maintain the day to day operations of the Cathedral and the primary functions of the congregation and have no capital preservation requirements. Operating Funds are classified into two categories:

Operating Unrestricted For general use

Operating Restricted For specific uses as specified by the donors

A portion of the Operating Funds are invested until Council utilizes the funds for their designated purpose. Income allocated to these accounts is added to the fund balance.

- 2.0 Council Restricted Funds have been restricted by the Council of the Cathedral (Council) for specific purposes and are invested for the long term. Periodically and as determined by Council, income allocated to these funds is transferred to the Operating Unrestricted Fund to support the cost of operating the Cathedral.
- 3.0 Endowment Funds have stipulations defined by the donors. The capital is preserved and invested for the long term. Income allocated to these invested funds is reinvested until the funds are utilized for the stipulated purpose.

#### **Investments**

Investments are held in units in The Endowment and Trust Investment Funds of the Diocese of Nova Scotia and Prince Edward Island and are professionally managed by Jarislowski Fraser Limited. Performance of the investment funds is reviewed on a regular basis by the Treasurer and reported to Council.

Additions to and transfers out of Investments within the quarter are carried at cost. The balance of the investments are carried at quoted market value. Changes in market value are recognized in net income in the period in which they arise.

Investments are subject to market risk, interest rate risk, currency risk and credit risk. These risks are mitigated through the use of a professional investment manager as outlined above and appropriate investment type (stock and bond), industry sector, security and geographic diversification.

# **Revenue Recognition**

Donations are recognized as revenue of the specified fund when received. Special event and other revenue is also recognized when received.

#### Investment income

Reflects the change in market value of investments held.

#### **Financial Instruments**

Other than investments, the Cathedral's financial instruments consist of cash and cash equivalents, receivables, payables and accruals. Unless otherwise noted, it is Council's opinion that the Cathedral is not exposed to excessive market, interest rate, currency or credit risks.

#### 4. Investments

In general, the Cathedral has benefitted from positive financial markets and capable management. Investment income has exceeded operating requirements. This has allowed the overall balance of the investment funds to increase on an annual basis. This is subject to change as financial markets enter a period of volatility.

#### 5. Related Party Transactions

The Cathedral is the beneficiary of income generated by a number of trusts held by The Anglican Diocese of Nova Scotia and Prince Edward Island and some funds held by Dean and Chapter. These funds are not recognized as assets of the Cathedral.

Dean and Chapter was established in 1858 to build and maintain the Cathedral Church of All Saints, Halifax, as a place of religious worship for the Anglican Church of Canada – Diocese of Nova Scotia and Prince Edward Island and holds title to the Cathedral Building. The Dean and Chapter receives investment income, land rent, occasional donations and bequests. The income is used to pay the mortgage on the property, some maintenance and operating expenses of the Cathedral as well as small contributions to other charities and an occasional bursary. Dean and Chapter also hold funds in trust for the Columbarium Fund. The Cathedral has an interest in the title of the land which is being leased on a long term basis by the Anglican Diocesan Centre Corporation to the Shannex Group Inc.
